PROGRAM OVERVIEW

H&R Block, Inc. strongly believes in civic involvement and corporate responsibility. One of the ways this commitment is demonstrated is through The H & R Block Foundation Matching Gift Program. The Matching Gift Program gives eligible associates of H&R Block and its participating subsidiaries an opportunity to determine how Foundation funds are allocated and allows associates to make significantly larger charitable contributions to educational institutions.

WHO MAY PARTICIPATE? To be eligible, you must be considered a regular, full-time employee* of H&R Block or a participating H&R Block subsidiary. Participating subsidiaries may include but may not be limited to: H&R Block Enterprises, LLC; HRB Green Resources, LLC; HRB International Management, LLC; HRB Resources, LLC; HRB Professional Resources, LLC; HRB Technology, LLC; and Sand Canyon Corporation.

*An employee who works 40 or more hours per week on a non-seasonal continuing basis and is classified as a regular, full-time employee within H&R Block's Human Resources system.

HOW DO I PARTICIPATE IN THE PROGRAM? Complete and sign Part 1 of the Matching Gift form and send it to the eligible educational institution. The institution must complete and sign Part 2 of the form to confirm its eligibility and receipt of your gift, and then forward it to the Foundation. The H & R Block Foundation will send a matching gift to the eligible institution and notify you after your gift has been matched. The deadline for submission of previous year's gifts is January 31.

WHAT GIFTS ARE ELIGIBLE FOR MATCHING FUNDS? Gifts must be paid, not merely pledged. Minimum gift amount is \$100. The Foundation matches gifts on a one-to-one ratio.

IS THERE A LIMIT ON THE AMOUNT OF MATCHING GIFTS? Each qualified individual is eligible to have up to \$1,000 in gifts matched each calendar year. Once your gift(s) total \$1,000, additional gifts that are made in the same year will not be eligible for a matching gift.

WHAT ORGANIZATIONS MAY RECEIVE MATCHING GIFTS? These types of organizations are eligible:

A college or university located in the United States which is accredited by one of the following regional accrediting agencies: Accrediting Commission for Community and Junior Colleges (ACCJC) Western Association of Schools and Colleges; Higher Learning Commission (HLC); Middle States Commission on Higher Education (MSCHE); New England Commission of Higher Education (NECHE); Northwest Commission on Colleges and Universities (NWCCU); Southern Association of Colleges and Schools Commission on Colleges (SACSCOC); and WASC Senior College and University Commission (WSCUC), or a school listed as an institution of higher education in the Higher Education Directory (published by Higher Education Publications, Inc.);

A nonprofit private or independent secondary school located in the United States which is accredited by one of the regional agencies listed above, or by an accrediting program approved by the National Association of Independent Schools (NAIS);

A college or university located outside of the United States which is recognized by the U.S. Internal Revenue Services as an organization to which contributions are tax-deductible and has a favorable 501(c)(3) Determination Letter from the IRS.

ARE THERE CONTRIBUTIONS THAT ARE INELIGIBLE FOR MATCHING GIFTS? Contributions ineligible for matching include: (1) payments for tuition, books, loans, or student fees; (2) subscriptions for publications; (3) pooled gifts made by an eligible donor on behalf of ineligible contributors; (4) unpaid pledges; (5) gifts for which the matching funds would provide more than the incidental benefit of recognition for the gift to the donor or the donor's family.

The Foundation reserves the right to approve or deny a matching gift request based on funding availability and/or the Foundation's determination that the request fulfills program criteria.
